# About the project

*EAST - Entrepreneurship as Self-employment tool. Skills and qualifications within ECVET* is an Erasmus+ KA2 project (Project number: 2019-1-ES01-KA202-064035) that started in October 2019 and has a duration of two years.




The main **objective** of EAST project is to develop a **training itinerary for entrepreneurship** / small businesses management following **ECVET** recommendations and thus applicable in different countries. The EAST qualification will describe the units and learning outcomes corresponding to the entrepreneur profile, and determine the required knowledge, skills and competences to become an entrepreneur. It will allow

flexibility in the training pathway thanks to assessment solutions and a modular structure. It will be summarised in a Europass Certificate Supplement to make it easily understood over Europe.

### **Completion of Intellectual Output 1**

The first intellectual output of EAST. entitled "Entrepreneurship as Self-employment tool. Skills and qualifications within ECVET" has been successfully completed. The development of IO1 produced a report where a needs analysis was done to collect the best practices of entrepreneurship and innovative educational approaches already in use in the partnership countries (Spain, Poland, Cyprus, Greece, Italy). It also identified the training needs and necessary steps for the successful implementation of open educational approaches in their daily practices. The second intellectual output of the project, **"Recommendations to create bridges between VET and higher education systems for entrepreneurship"**, has also been completed with success. Despite the difficulties that the partners were facing due to the COVID-19 crisis, the consortium managed to remain productive and complete IO2 with great results. In particular, IO2 consists of two parts:

- **Part 1:** Basic assumptions → With information about the VET/ECVET systems in the partner countries, confirming learning outcomes in the area of entrepreneurship, a comparative research and recommendations for validation.
- **Part 2:** Validation methodology → With information about the approaches of validation, the validation process, validation methods, validation advisors, certifying institutions, the quality assurance of validation and extra recommendations.

### **Online Meeting in July 2020**


